Satisfactory Academic Progress Appeal Graduate & Law Students

Federal Regulations require all institutions of higher education to monitor Satisfactory Academic Progress (SAP) and ensure that students receiving financial aid are making progress towards degree completion. Your academic performance is reviewed each semester to verify that you have completed the required number of hours (pace), maintained the minimum grade point average, and have not exceeded the maximum number of cumulative attempted hours allowed.

Graduate and Law students who are not meeting the pace or cumulative SAP standards after one semester of warning lose financial aid eligibility for federal student loans and work-study. Ineligible students have the right to appeal. SAP Progress appeals are denied or approved on a case-by-case basis. Final decisions are based upon your written appeal and the documentation submitted. You must provide details of the extenuating circumstances related to your situation.

Satisfactory Academic Progress Requirements:

• **Grade Point Average:** Students-at-large and graduate students must maintain at least a 3.00 cumulative GPA (CGPA). Law students must maintain at least a 2.20 CGPA.

Note: Failure to maintain the grade point average requirement also has implications regarding academic status. For additional information on GPA and Academic Status, see "Academic Probation and Dismissal" in the appropriate catalog.

• Rate of Completion: A student must successfully complete at least 67% of the credit hours attempted. Graduate courses in which grades of *A*, *B*, *C*, *P*, *S* or *IP* have been earned are considered to be successfully completed. Enrollments resulting in withdrawals, incompletes (grades of *I* or *IN*) and courses in which grades that are not passing have been received are not considered successfully completed but may be counted in the hours attempted. Law courses with a grades of *A*, *B*, *C*, *D* are included in earned hours.

Maximum Timeframe Requirement

Federal law limits the maximum timeframe for which a student can receive federal financial aid including student loans. To continue to be eligible for federal aid, total hours attempted must not have exceeded the maximum number of credit hours established for their program and listed in the following table. Maximum timeframe exceeds minimum program requirements and can accommodate electives, internships, disruptions in enrollment, changes in concentration, and work on thesis or dissertations with careful planning. Student-at-large (SAL) hours and credit hours accepted for transfer courses are included in hours attempted.

All graduate course work, including SAL and master's credit hours, will be included when determining maximum time frame for Ph. D. students.

<u>Graduate Change of Program</u> - In the appeal process one change of graduate program will be considered. No appeal will be considered for additional graduate program changes.

<u>Graduate Additional Degree</u> - In the appeal process pursuit of a second master's degree will be considered. No appeal will be considered for additional master's degrees.

No appeal will be considered for more than one Ph.D.

Appeals Procedures - Appeals must be submitted to the Financial Aid and Scholarship Office.

Special circumstances include but are not limited to

- documented medical circumstances
- documented learning disabilities
- documented death in family
- personal or family crisis

The following reasons will not be considered as special circumstances:

- not performing well academically
- not adjusting in general to college life and/or academics
- changing academic program more than once
- being a transfer student
- working beyond a master's degree level without admission to a doctoral program
- taking courses not required by program to establish enrollment level eligibility for an assistantship or fellowship The Financial Aid and Scholarship Office's appeal decisions are final and cannot be overturned by the U.S. Department of Education.

- Changes of major of program that occur after an undergraduate student has attempted 120 hours will only be allowed if recommended by an academic advisor and it is unlikely the student will be able to complete the current major.
- If a student has taken all courses required for a degree or certificate program, the student is no longer eligible for financial aid even if the student has not applied for graduation.

List the required courses remaining to complete degree: Students who have exceeded maximum timeframe and have an approved appeal based on an extenuating circumstance may only receive financial aid for the shortest path to degree completion. Only the minimum courses required to complete the degree are eligible.

Courses for minors, double majors, areas of specialization or certificates that are part of a degree program or other courses associated with the students program are only eligible if the degree cannot be awarded without completion of the course. Please note, the maximum timeframe limit provides opportunity for students to take additional coursework for these reasons, it is only after maximum timeframe is exceeded that these course restrictions apply.
